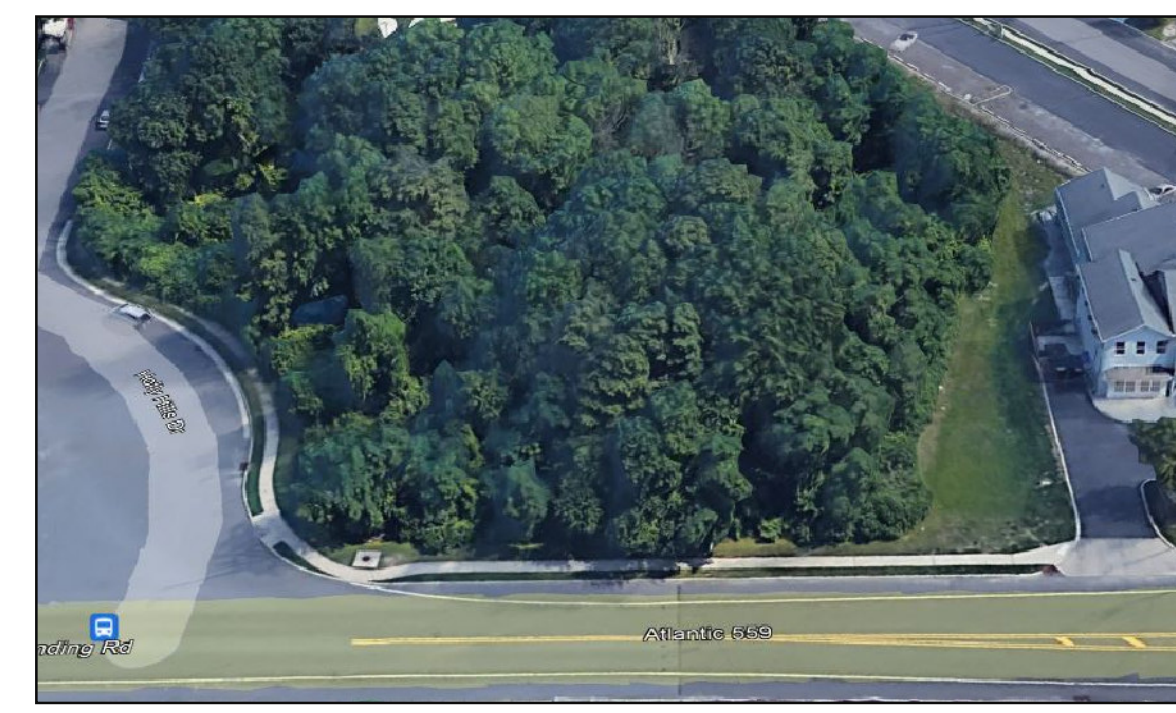

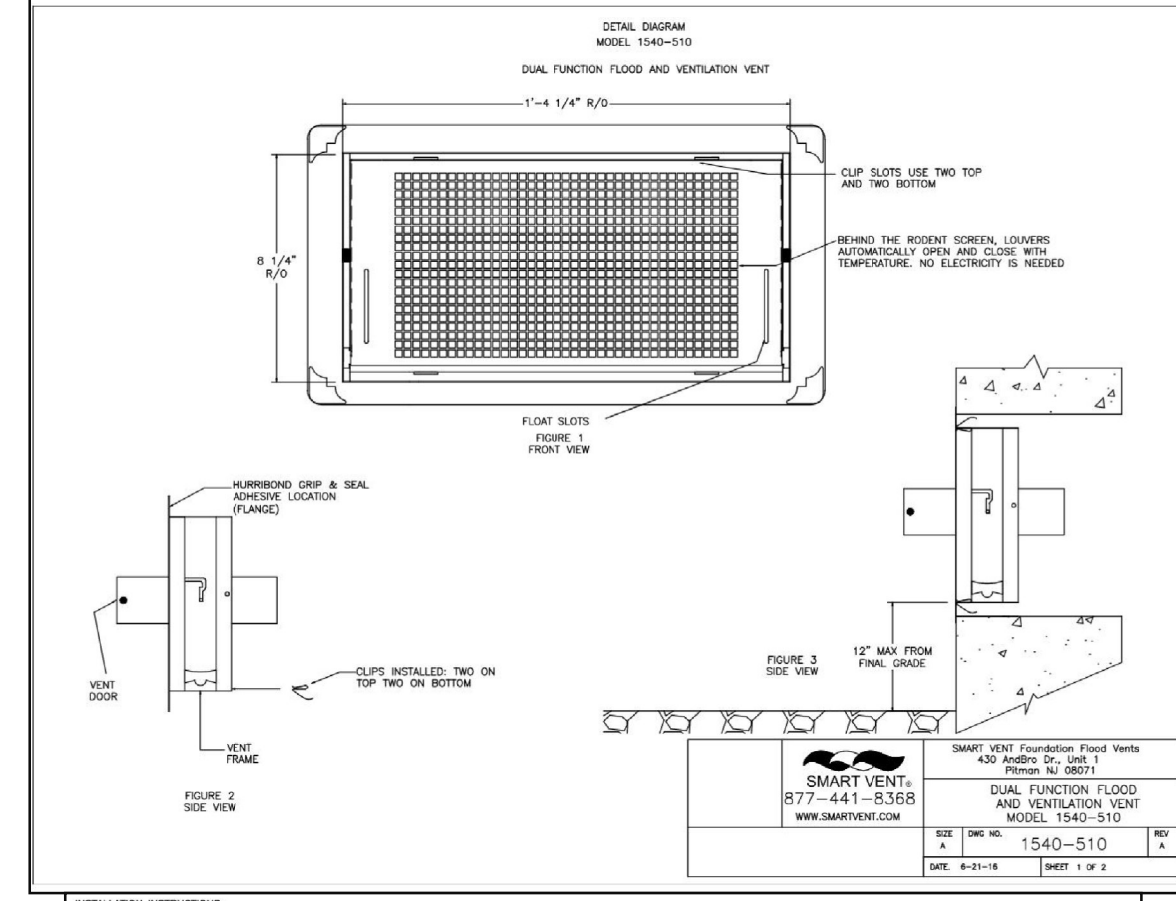
QUAD MAP
